This is the sixth consecutive year we are honoring a hero dog, and

the third consecutive year for a service hero dog.

If you see in your local paper or club newsletter a write-up on a German Shepherd Dog performing a heroic deed, please let me know. Send all particulars, the clippins, name and address of the owner, etc.

Our service Hero Dog cannot be present, nor either of his two handlers, Chief of Police in Brookfield, Wisconsin, Jerome R. Wolff,

advised in a letter with documents about the dog.

Sir Buff Braxton or McDuff, as he is called by his handlers, Scott Smith and Ronald La Gosh, was purchased from Alma Sales, Inc., in El Monte, CA., on April 6th last year. The dog's trainer came with McDuff to instruct the officers, and then he returned to California.

On February 5th of this year, the department was notified about a burglary suspect who was attempting to escape in a stolen vehicle. Earlier, he had stolen another vehicle, was sighted by an officer and was fleeing on foot. McDuff and Officer La Gosh were called to assist. It was sub-zero weather. The ground was covered with an inch of snow, and more was falling as the solid black dog off leash tracked nine miles with La Gosh and members of the Waukesha Sheriff's Dept., the State Patrol, and other Wisconsin officers in hot pursuit. The suspect backtracked a lot, weaving in and out of fields, subdivisions, a golf course, apartment house complexes, and parking lots. It was thought he was checking autos for keyes in the ignition. At 5 a.m., the 26-year-old man was apprehended. It was discovered later he had a long list of criminal activities.

Said Chief of Police Wolff, "Canine McDuff is credited with outstanding performance. He stayed on the track and never faltered in his pursuit of the suspect. Our police dog helped to motivate the officers involved in the chase; his energy and stamina often surpassed that of the officers."

Our treasurer, Eugene Tenges, who lives in the area, will accept the award and see to it that McDuff is honored in Brookfield.

The hero dog who performs a heroic act through instinct rather than

by training is Wahabi Luke, this year's winner.

Victor Iannicelli, Luke's owner, was sound asleep in the early morning hours when he was suddenly awakened by a loud bang on the bedroom door. The banging did not stop. "Luke," he said, "it's not time to go out; it's still dark." There was another loud bang as the dog threw his weight on the door. "Now what could be the matter with Luke," Victor murmured drowsily. "If he wants to go out, he scratches on the door. I wonder what's the matter."

Victor got up, went to the door, and was met by a blast of hot smoke. His wife, Rena, also awakened by the unusual commotion, screamed as the smoke billowed into the bedroom, "Get Vic; Get Vic." Victor stumbled through the dense smoke to the basement steps. Victor, Jr., slept in a basement room. "Vic, where are you?" he yelled down the stairs. "I'm here," answered his son, "but I can't find the stairs." The smoke was so dense that neither could see the other. "Follow my voice," yelled Vic, Sr. With what seemed an eternity but was really a few minutes, father and son were together in the kitchen. Both along with Luke raced through the suffocating smoke to get everyone out of the house including the second floor occupants. When

it was thought everyone was out, there was no Luke.

"Luke, where are you?" Victor bellowed. The firemen had arrived and were setting up hoses and ladders. "I think he went inside to look for more people," said one. "It's amazing," said another, "usually a dog is the first one out, not the last." Luke emerged from the door, just as a huge blast from the cellar shattered the roof, and flames gushing from the cellar engulfed the entire house and soared through the broken roof high into the sky. No one was hurt, including Luke, who had saved the entire family when minutes count.

NOTE: Luke and his owners came to the Philadelphia annual meeting awards presentation to receive his silver engraved medal affixed to a red, white, and blue ribbon. Club President Helen Fisher put it around his neck. Photographers took numerous pictures amid an overwhelming standing ovation from the entire membership assembled.

The GSDCC Inc. has been forced to accept the Canadian Kennel Club's directive that "whites and off colours" be considered as "Very serious faults". The CKC's reason for refusing to allow the GSDCC Inc.'s proposal for disqualification is their contention that the German Standard does not consider white as a disqualifying colour. We hope changes to the Canadian Standard for German Shepherd dogs will take effect promptly.

Regretfully, I hereby resign my position as Liaison Officer, G.S.D.C.A. Inc. effective January 1, 1990. I have enjoyed the opportunity of serving in this capacity, however, my husband, Peter, whose term as President of the G.S.D.C.C. Inc. will be over at the end of February, 1990, has been in ill health over the past year. Both of us have served for many years on the Canadian Board and we now feel that it is time to step down and devote more time to our own dogs with regards to breeding and showing.

SPECIAL AKC BULLETIN

Instructions For Obtaining **A Limited Registration Certificate**

In an Issues survey undertaken in 1986, 79.9 percent of the delegates and 83.6 percent of GAZETTE readers who responded agreed or strongly agreed with the statement: "AKC should provide a not-forbreeding form of registration." This response initiated the process of establishing a limited registration option to serve as another choice for breeders who wish to limit the breeding of a dog but do not wish to sell their dogs without papers, or who do not want to have their dogs neutered or spayed, though they will be ineligible to compete in a licensed or member dog show.

At the June 1989 delegates' meeting, the limited registration option was formally approved. It will be numbered Section 4A of Chapter 3 of the Rules Applying to Registration And Dog Shows, and will be added to the field trial rules for Bassets, Beagles, Dachshunds, Retrievers, Spaniels and Pointing Breeds. Dogs with a limited registration can participate in obedience trials, tracking tests, hunting tests and field trials.

The following instructions are for obtaining a limit-

ed registration certificate:

Effective January 1, 1990, there will be a change in Section A of the reverse side of each registration application form issued. At present, there are two boxes which can be checked in Section A of each application. Effective January 1, there will be three boxes appearing in Section A (see illustration).

In order to obtain a limited registration certificate, the litter owners would check Box #1 in Section A of the registration application form, and all litter owners would be required to sign Section A. No other information should be completed on the reverse side of the application. On the face of the application, a name choice as well as the sex and color of the dog should be indicated. The application should then be submitted with the required registration fee of \$6. The applications should be submitted to the attention of Department L.

The litter owners will then receive a limited registration certificate (see illustration). The certificate will clearly state "Offspring of this dog not eligible for reg-Istration." The certificate will differ from the present certificate in that it will have an orange border rather

than a purple border.

If the dog is sold or given away, the reverse side of the certificate would be completed by the owner(s) in Section A indicating the particulars of transfer to the new owner. The new owner would complete and sign Section B and submit the certificate with the required transfer fee of \$6. The dog will continue to carry the limited registration regardless of the number of times the dog is transferred.

If you have a dog that you wish to have granted a limited registration certificate and for which the application was issued prior to January 1, 1990 (if you have an application without the appropriate box for limited registration designation), you may exchange the application at no charge for a period of six months. Simply submit the application with a note requesting that a new application be issued. The application should be sent to the AKC, attention Department L. However, after July 1, 1990, any request to exchange applications must be accompanied by a fee of \$6.

As stated above, once a dog is registered with the limited registration, the dog will continue to carry the limited restriction regardless of the number of times the dog is transferred. The registration status can only be changed from limited to non-limited if all the litter owner(s) agree. A special form will be provided by the AKC to be completed by the litter owner(s) as well as the present owners for this purpose. A fee will be charged to change the registration status of the dog at that time.

If a dog is registered without restriction, and if at a later date the owner, who was not the litter owner, decides that the dog in question should not be bred, the dog's status cannot be changed to a limited registration. However, the owner would have the option of selling the dog either without papers or under a

spay/neuter agreement.

And Keep in Mind

It cannot be emphasized too strongly that the decision of whether or not the dog will be sold with a limited registration should be made prior to the time the dog is sold. That way the litter owner will have the limited certificate available for the purchaser at the time of sale. If, for some reason, the certificate is not available at the time of negotiating the sale, the litter owner should clearly advise the buyer or the recipient that the dog must first be registered in the litter owner's name and that the buyer will then be furnished with a limited registration certificate. The sale should not be consummated until the limited certificate is available.

Any correspondence or applications in connection with the limited registration should be sent to the

attention of Department L at AKC.

The offspring of a dog registered with a limited registration certificate are not eligible for AKC registration. Therefore, if you intend to register the offspring of a mating between your dog and another dog of the same breed, it is incumbent on you to be certain that the dog is registered with full registration privileges. and that the person who represents himself to you as the owner of the dog is the actual owner of record. The only way to determine this is to demand to see the actual registration certificate for the dog before a mating takes place.

The person who represents himself as the owner of the dog should be named as the owner on the face of the registration certificate. If the dog is not yet registered or transferred, or if the owner is not able to present to you the actual registration certificate, do not breed to this dog. Do not accept a pedigree as proof that the dog is registered or eligible for registration or

that its offspring can be registered.

A dog registered with an AKC limited registration shall be ineligible to be entered in a breed competition in a licensed or member dog show. It is eligible, however, to be entered in any other licensed or member event.

A full AKC registration certificate is white with a purple border. The limited registration certificate is white with an orange border.

HERBAL MEDICINE

by Daphne Szczuka*

Herbal medicine has been practiced in many forms for centuries, and a recent interest in the return to "natural" products has brought this time honored method of healing and health into the spotlight again. These herbal treatments have been used by breeders for years with great success. All of the herbs mentioned here can be found in grocery stores or health food stores.

PREGNANCY

- Red Raspberry Leaf Tea -- When used regularly before whelping, it seems to have the effect of making the whelping easier and generally trouble free. Use between a teaspoon and a tablespoon full a day, mixed with the food, from four weeks until whelping.
- 2) Thyme -- Strengthens uterus when used during pregnancy. Use 4 teaspoon of ground or one teaspoon of whole thyme.

PANO

- 1) Alfalfa -- Reduces inflamation and pain. Also improves appetite. Give 200 mcg Vitamin B-12, 7 tablets of alfalfa, and 2000 mg of Vitamin C. (Add Alfalfa and Vitamin C slowly to diet -- can cause dirrhea if given suddenly)
- Comfrey -- Famed for its powers upon bones and ligaments.
 Reduces imflamation by improving circulation to injured area.

GAS

There are many herbs that aid in the expulsion of gas and can improve bad breath as well. Although it would be hard to prove, it is very possible that these herbs could at least reduce the risk of bloat, if not prevent it. Mixing parsley, marjoram, rosemery, and thyme in equal parts works better than using only one of the herbs. Give one tablespoon in food.

COAT

Thyme and Sage can retard hair loss by improving the superficial blood vessel system which feeds the hair roots. Use $\frac{1}{2}$ teaspoon of ground herbs or one teaspoon of whole herbs.

There are many more herbal remedies, but these address specific problems that dog breeders and owners often face, and provide solutions that can be easily followed.




