Dear Friends of the K-9 Corps Memorial,

Not long ago I learned that Ebony had ultimately ended up as a soldier with the South Vietnamese Army. As we pulled back, and then pulled out, the dogs carried on. They were not permitted to go home. I can only guess as to how it must have been for Ebony after I went home, and it grieves me deeply to picture it. I imagine that she was broken-hearted, but that she carried on as a proud troop until the terrible end. She deserves an honorable grave site. She earned the "thanks" of the American people, and with your help she, and the others, will be thanked.

And speaking of thanks, we can all be thankful for - Barb Bronson in St. Louis, Joy Dysart in Ohio, former dog handler Jim Doney of Maryland, and the Fayetteville Kennel Club. Without their generosity we would not have made it through the summer, and none of you would have gotten our news letters.

Although the above named people have been especially helpful, there is yet another group that is to be thanked, as they are helping us to grow. You see, our Memorial Army is on the march, and enlistments are on the rise. Some 27 enlistees have been added since the 4th of July, and a record 10 dogs were added on July 4th. Another enlistment record was recently broken, when Janis Comstock-Jones of Ohio enlisted 6 of her animals.

And I would add that one of those six was a horse. Yes, other animals can be enlisted, as this is exactly in keeping with the original Dogs For Defense program. Our new recruits are - JOE, CHI CHI, HOLLY, SARGE, HEIDI, SAM, TARA, MEG, BUTCH, AXEL, BEAR, JUSTIN, CARPICE, RAVEN, ROCCO, MOLLY, MAJOR, SNICKERS, VODOO, LUCKY, AMES, FLASH, FIRE, JAKE, COSMO, BITSY, and SPARKY (the horse). These enlistments help. They are very important to us, and a vital part of our growth. If you have not yet enlisted your pet, then surely all of the above named soldiers would encourage you to do so today.

I am very much encouraged by the recent increase of people who are adding their dogs to our memorial army. But, I believe that we can do better, much better. In fact, I am a bit disappointed by the fact that most of you have not enlisted even one pet, though you profess to "support" this struggle for a K-9 Corps memorial. Many of you have been enjoying more than 10 issues of our news letter, for free, at a cost to us that is far from free, yet you are unable spend as little as \$3 to enlist a pet in support of our efforts. Come on people, drop us a line today! Let us know that you are still behind us! Be a voice for those brave soldiers who had no voice.

Now here is a good example of exactly what I've been talking about. Our last report invited you to help us in giving a name to our newsletter. Not a one of you responded. But, there was a response. It came from that person who is far and away our greatest supporter, my Wife. And believe me, without her there would be no memorial project. Her suggestion is that we call it "FIRST ALERT". Now there is still time for one of you to come up with something better, but you have got to hurry. We hope to come out with a new format in September. And by the way, if your business or club is interested, we will be

A raffle for a quilt was won by Marilyn Balsman.


A brag box was held.

FROM THE EDITOR'S DESK:

Our newsletter (The Wag-N-Tongue) is an important part of the functioning of our club. We use it as a meeting notice, to tell you when something important has happened, to brag on our dogs, and to send messages. Our members who cannot attend our meetings are able to stay up with what is going on through our newsletter. And that is important.

Getting the newsletter printed and mailed is an enormous project, and often I do it alone. So, due to the limited time in which I have to prepare the newsletter, I must request the following changes in policy:

- 1) No ads (unless the event is sudden, i.e. the death of a dog) will be accepted over the telephone. Ads must be sent, with payment, to the editor no later than the Monday following the club meeting. Ads do not have to be camera-ready, although this is preferable. Ads should be written out, using whatever wording is desired.
- 2) The cost of purchasing the cover will now be variable:
 - a) If the picture is of the corecct size and black & white, the cost will be \$25.
 - b) If the picture is color and must be screened; or reduced, enlarged, or anything that would require the services of the printer; the cost will be \$15 plus the cost of the printer's work.

I hope this will make the job of the newletter editor easier.



Holly belongs to South Sider **BARBARA BRONSON**, local representative of the group. "People say that first we need a memorial to all the women who served in wartime, and they're right," she says. "But there are a lot of men and women veterans walking around today who wouldn't be here if these dogs hadn't gone to war." Last night, I was very involved in an important project when my wife said it was feeding time and needed my help. I explained to her how busy I was, but I guess she doesn't believe in me keeping the world safe for democracy from my easychair. So, I turned off the computer game and went to help her.

This night, we had five HUNGRY mouths to feed; our three and two up from Memphis for the dog shows in St. Louis. There is no doubt that it is feeding time; Kahla has been announcing to the world for 30 minutes that her owners are cruel people who never feed her (our neighbors who hear this sob story twice a day, every day, tend to ignore it).

My job is to go outside and bring in as much dry dog food as I can carry, plus a couple of cans. Lola is also finicky, but if she is outside with the others, she is so busy trying to get them to play, she forgets to eat. So we bring her in the house and let her watch us fix dinner for five. This really improves her appetite.

At least the dogs don't have a show every day. Last Friday I worked three hours overtime and came home hot, tired and hungry. I walked in the door and the whole house smelled wonderful! I could smell onion, beef broth, oregano, and a whole multitude of mouth-watering smells. "Daphne! What's for dinner?!" I asked. She said "This is bait for the dogs. I put you a pot pie in the oven". I looked over the king's feast she was cooking the dogs and thought 'I know who rules this castle'.

K-9 Police Dogs More Humane Than Bullets

Bear, a regal-looking black and tan German Shepherd, received the German Shepherd Dog Club of St. Louis' 19th annual award for Outstanding Service Performed by a K-9 Dog Belonging to the St. Louis Metropolitan Police Force Sunday afternoon in Sioux Passage Park.

Bear, who was among six police dogs nominated, had tracked a robbery suspect in pouring rain, found the subject in a basement and continued to search until he nosed out the stolen property in another area.

For his prowess, 4-year-old Bear and handler, Police Officer Edward Meyer, were presented with an engraved walnut plaque during intermission at the breed club's specialty show and obedience trial. All six of the outstanding K-9 nominees received certificates of merit and German Shepherd medallions.

Special recognition was also accorded K-9 retiree Beauregard, who with handler Charles Robertson, is going to work in bomb detection for the City Sheriff's Department. The first dog to join the Sheriff's office, Beau received his official badge from Sheriff James Murphy.

Lieutenant Joseph Richardson, commander of the K-9 Corps unit, and guest-of-honor, Lieutenant Colonel Calzona Hall, Deputy Chief, Bureau of Field Operations, St. Louis Metropolitan Police,

accepted plaques honoring the outstanding dogs and the retirees for 1988.

Nancy Kearney, K-9 Corps liaison and public relations director for the German Shepherd Club, said that the club adopted the K-9 Corps as a civic project to give back something to the community and to publicly recognize the service the police dogs perform.

"These dogs are the most efficient, effective and inexpensive tool in the police department," Kearney said. "They search buildings, find articles, track lost people, work in crowd control, detect bombs and narcotics. They are trained to bring down an armed suspect, but they are more humane than bullets. A policeman can call back a dog. He can't call back a bullet."

BEAR handled by Police Officer Edward Meyer (DOB 12/21/85 DSD 8/7/87) tracked a robbery suspect after other officers had lost the man in a foot race. It was pouring down rain and the track was about 1/2 hour old. Bear found the subject in a basement, then continued to search until the stolen property was found in another area, thereby assuring a conviction. Bear is trained in bomb detection. WINNER

BERT handled by Police Officer Joseph Micciche (DOB 3/9/83 DSD 6/14/85) A major car theft ring was shut down because Bert caused all 5 suspects to be apprehended at once. Without Bert some of them would have escaped and all the vehicles would not have been recovered. Bert distinguished himself by winning the Paul McCoulough Award this year. He is trained in narcotics detection.

BUCK handled by Police Officer Michael F. Johnson (DOB 4/11/86 DSD 12/24/87) An armed and dangerous robber ignored orders to surrender. Buck was sent in and brought down the subject. Because of Buck's actions the criminal was caught and no officers were injured. Buck is trained in narcotics detection.

CHAMP handled by Police Officer Kevin Melchior (DOB 1/89 DSD 8/7/87) tracked a suspect through difficult city terrain to a dumpster. The man jumped out of the dumpster and knocked the officer backward. Champ went to his handler's defense and stopped the subject from escaping. Champ found several burglars, recovered a great deal of stolen property and was responsible for the seizure of thousands of dollars worth of drugs.

CLYDE handled by Police Officer Stephen Holt (DOB 5/28/84 DOS 12/12/86) was responsible for closing down a cocaine dealer and the seizure of currency believed to be drug money. The fact that the "dealer" was a corrupt police officer makes this arrest of great significance.

CON handled by Police Officer Lawrence Keating (DOB 12/84 DSD 5/7/87) Detectives surrounding a large 3 story building called for assistance from the Canine Unit. Con located the juvenile who was wanted for several shootings, including one fatality, in the sub-ceiling of the basement. The subject is now confined on charges of Murder 1st Degree, 3 counts of Assault 1st Degree, and 4 counts of Armed Criminal Action. Con is trained in bomb detection.



THE HIP DYSPLASIA CONTROVERSY

Misunderstandings regarding the causes of canine hip dysplasia have been fueled recently by dog food advertising that appears to suggest this crippling hip-joint disease can be overcome by following a specific diet.

These claims, combined with misinterpretation of an obscure data base that geneticists call the heredity index, have fostered acceptance of the idea that hip dysplasia can be the result of environmental rather than genetic factors.

"Unfortunately, it just isn't true," says Dr. E.A. Corley, director of the Orthopedic Foundation for Animals (OFA). "There are no environmental causes of hip dysplasia. Scientists have repeatedly demonstrated that dysplasia is only controllable by selective breeding."

Nutrition can, however, influence the onset and severity of dysplasia in pups genetically predisposed to the disease, Dr. Corley explains. Such pups, raised on a high-calorie diet, demonstrate dysplastic changes that are earlier and more severe than those of littermates raised on a lower-calorie diet.

The OFA is a nonprofit registry devoted to collecting information concerning orthopedic diseases in animals. Its internationally recognized hip dysplasia registry

(the world's largest) has X-ray files on about 300,000 dogs whose hips have been examined and then rated by a team of affiliated specialists in veterinary radiology.

OFA certification of a dog's hips has become a breeder's hallmark of excellence. Dogs with hips certified as normal have the lowest chances of producing pups with dysplastic tendencies. In fact, the day can be foreseen when OFA hip certification will be shown on registration papers for the various breeds.

Among gundogs, whose running power is a major factor in their usefulness, strong, well-formed hips are of primary importance. Top performance requires a good fit of the hip's ball-and-socket joint; such a fit smoothly transfers the driving force of the rear legs to the rest of the dog's skeleton.

In dogs having dysplasia, the fit is loose, allowing the ball to slip around against a flattened socket. This slippage is painful in some dogs. Those with a lesser degree of dysplasia manage to hold the hip in place by developing extra muscle layers at the site. Still, they tire more easily and their performance can be expected to decline earlier than that of dogs with normal hips.

The accuracy with which dysplasia can be spotted in X rays depends on the dog's age and breed. Only about 15 percent of dysplastic pups may show the deformity at



All breeds can carry dysplastic genes.

6 months of age. Deformities may be evident in about 68 percent of cases by 12 months, 80 percent by 18 months, and 95 percent by the time the dog has reached 2 years of age. For this reason, the OFA grants certification only to dogs at least 24 months old.

Breeders seeking ideal breeding stock often submit X rays to the OFA every six months to check on the status of a developing pup. If dysplasia is spotted early, it will not go away, and

the breeder can disqualify the dog as breeding stock.

Since hip-joint construction varies from breed to breed, no single standard of excellence applicable to all breeds exists. Only veterinary radiologists with broad experience are qualified to analyze X rays submitted to the OFA. In each case, the X rays are taken by a local veterinarian and then sent to the OFA, where, for a \$20 fee, each is rated by three specialists.

OFA examination is confidential. The radiologists know only the breed, age and sex of the dog whose X rays they review, never the name of the breeder or individual dog. Only the breeder is notified when a dog fails to pass.


DON'T OVERFEED PUPS

Overfeeding does not cause hip dysplasia, but it can exacerbate the effects of the disease and may bring the symptoms on early.


As normal pups grow, the ball of the hip joint is pulled by strengthening muscles against a soft formative bone that becomes the joint socket. In pups harboring genes predisposing them to dysplasia, the formation of the joint will be faulty to some degree.

Overfeeding during the growth stage causes the pup to put excessive weight on the joint as it forms, thus exaggerating the slippage that is likely to occur. Keeping dysplasia-prone pups on a lower-calorie diet can minimize this effect.

Check with your veterinarian to choose the correct diet.
